### **Discussions of places to hold next Conference**

- Qwest comments:
  - Very Nice but big
  - May be able to negotiate on the price
- Hilton comments:
  - Will not book us till 12 months prior to event due to the amount of rooms reserved
- Double Tree in Omaha comments:
  - Might need to cut back on vendors
  - Jim L. will acquire a proposal

- University of Omaha Comments:
  - Eric will talk to Karissa and look into this facility
  - Will tour this next month if it looks good
  - Eric will obtain a proposal if this looks like it may be an option
- Holiday Inn Kearney comments:
  - They are shooting us a very strong deal
  - Looks good for 2009 symposium
  - Only dates available for 2007 are May 22, 23 and 24
- Cornhusker in Lincoln
  - Raising prices by \$8,000 due to lack of reserved hotel rooms
  - Raising the conference fees \$30 would cover this
- Cities
  - Omaha
    - Would like to have in Omaha first
    - Might get Iowa people if in Omaha
    - Might lose some Lincoln people
    - Might gain Omaha people
    - Need Omaha support
  - Kearney
    - Will people travel
    - Might not have as many registrants but will not cost as much either
    - Reach out to greater Nebraska
- Next month have all proposals available and decide on location

- No permanent decision on place but looking at Omaha for 2007 and Kearney for 2009.

## **GIS Certification**

- Two different types of certification ASPRS and GISCI
- Created a subcommittee of Scott, Paul and Jim to look into ways that the GIS/LIS Association could provide information to help anyone wanting to become certified
- Address reasons why people may choose not to get certified

    - Larry Zink will forward on the summary of the presentation to his contacts with Nebraska Association of County Officials and League of Nebraska Municipalities

    - Bonnie S. will post the summary on the ESRI GIS day website
- Annual Meeting
  - Mahoney State Park
  - Jim L. will talk to Ed to get information or possibly arrange this.

- MAGIC Symposium
  - GIS/LIS board voted yes to have a \$300 sponsorship level. With this comes 1 free registration

- LR99
  - Any data held electronic or otherwise is public record regardless of format
  - 3 categories
    - Software applications written in house
    - Release information with agreement of no resale versus reasonable cost
    - Is email considered a public record?
  - Looking at two state models: North Carolina and Iowa
    - North Carolina has the data available but not for resale
    - Iowa has the data available for a reasonable cost
  - Concern over sharing data with National Map

- Do not want the flow of information to be blocked between local, state and federal agencies.
