The association is still looking for an overall program chair.

There was discussion with Paul in Kearney about becoming the program chair. He stated he would like to be involved but with an unknown class schedule and not sure of the amount of time he can commit to the symposium, he is declining at this time.

Mike S. has documentation ready to guide new chairperson.

Ed Kelley volunteered to ask his supervisors about aiding the overall Symposium chair. John and Ed will ask their supervisors about taking the overall chair position on.

The website for the symposium will be a major time consumer of the chairs time. Options need to be thought through on giving attendees the ability to register online, questionnaires on line, etc. There is a lot of time put into registering participants. If this time is reduced, the symposium chairs job will become easier. Need to gather additional information on this subject. John will call Mike and get additional information. One of the most crucial issues of the symposium chair is to get commitment to recruit presenters.

## **Annual Meeting**
