### Award Eligibility

GIS Professionals: Individuals, Groups, Organizations; or GIS Students

### Nomination Process

Only one copy of nomination should be submitted. All submissions will become the property of the Nebraska GIS/LIS Association and will not be returned. Generally speaking, the more information provided in the nomination, the better. *(Each nomination should contain this completed form, and the brief report. Additional information is optional.)*

### Provide brief report and optional additional materials:

A written brief report, using the following suggested guidelines:

- Brief report must identify submitting author (s) and affiliation
- Brief report should be from one (1) to no more than eight (8) pages in length
- Describe as many aspects as possible, addressing suggested criteria for particular award (see 2nd page)
- Illustrate why and how the person or team of persons is deserving of the award
- Articulate why the accomplishment is noteworthy
- Report may include comments, recommendations, or other relevant info
- Include background information to explain significance of the work
- Optional supporting materials:
- Digital or Printed Media
- URL link to a web site that further explains or illustrates work

### Report Format:

1. As much as possible, follow suggested format guidelines for the particular award. Uniform responses will aid the award selection committees in making fair comparisons. Format varies depending upon award type.
2. All possible key elements and their bulleted points should be uniquely addressed for the particular award:
  - a. Purpose
  - b. Design or Description of Qualifications
  - c. Implementation
  - d. Impact (Overall, Community, Organizational, or Educational)

### Nomination Origin

You may nominate yourself. Nominations can be made by and for individuals, groups, departments, organizations, agencies, businesses and any combination thereof.

## How to Apply

Any individual or team can submit an entry on behalf of their respective nominees within the state of Nebraska. Applicants should submit three copies of the completed nomination form along with a short technical paper (1-8 pages) describing how the nominated individuals have demonstrated one or more of the provided criteria, at a level of excellence that sets them apart from their peers. Ideally the nomination submission for the Excellence in GIS should describe an extraordinary approach, contribution, development or commitment to geographic information systems technology development in Nebraska. A panel of GIS experts from within the state of Nebraska will judge submissions.

**Excellence in GIS Education:** Created to identify GIS educators who have established or furthered an exemplary GIS educational project, course or program within an educational setting in a private or public school, college or university in Nebraska.

**Nominations should detail one or more of the following criteria:**

- Commitment to GIS and GIS technologies
- Leadership in technological developments and applications
- Comprehensive analytical approach
- Sets an example for the GIS community
- Notable contributions to/impact on local community, state, region, etc.
- Unique and comprehensive approach to application

## Suggested Guidelines for Excellence in GIS Education Award

### Purpose

- Why is the educator's GIS course, project, innovation, development, and/or implementation exemplary?
- What sets this educator apart from her/his GIS peers?

### Design

- Describe the motivation behind the course, innovation, project, development, and/or implementation.
- How is GIS technology used within the course or project developed or implemented by this educator?
- What is accomplished or learned by students involved in this course or project?
- Innovation implementation of GIS technology within the classroom?

### Implementation

- Explain the implementation phases and decisions.
- Clear communication of GIS application for education.
- Describe the unique course, project, application.

### Impact

- How does the project, innovation or education contribute to GIS development in Nebraska?
- Define who is impacted.
- Ultimately, what educational benefits have resulted?
- Describe its quantitative and qualitative impact.

### 2019 Nominations Deadline

All nomination requirements must be submitted a month or so before the meeting at which the Award will be presented. Award nominations for the 2019 Meeting must be submitted by **March 22, 2019.**

### Award Recipient Determinations

Evaluated based on criteria for each award and judged by a select sub-committee partly comprised of individuals working within the award realm, i.e. the Excellence in GIS Education award selection Committee will include education professionals who specialize in GIS.
